## Iran: Reports Say 12,000 Killed in Just Two Days, Evidence Still Emerging

### Reports: 12,000 Dead in 48 Hours

Executive Summary

A rapidly expanding body of photos, videos, and eyewitness testimonies emerging from Iran indicates mass civilian casualties within a 48-hour period on 8-9 January. While figures remain under independent verification, multiple sources report fatalities potentially reaching into the thousands, with some claims as high as approximately 12,000 during that short timeframe. Preliminary reviews of the visual material and testimonies further suggest that a significant proportion of those killed were young people, many reportedly under the age of 30. These claims require urgent, independent verification.

### What Is Being Reported

Over recent days, visual material from multiple locations across Iran has circulated widely. Across different sets of images and testimonies, consistent patterns appear:

- Lethal force used against unarmed civilians
- Direct gunshot wounds and mass casualties
- Bodies collected in large numbers within enclosed facilities
- Rapid removal and concealment of the dead
- Severe restrictions on information and access

At the same time, near-total internet shutdowns and restricted access for independent journalists and observers have severely limited on-the-ground reporting.

### A Striking Pattern: The Age of the Victims

According to initial assessments of the circulating visual material and eyewitness accounts, a notable and disturbing pattern has emerged:

many of the victims appear to be young—often in their late teens and twenties.

While ages cannot be conclusively confirmed without official records or independent access, multiple sources consistently report that a majority of the deceased were under 30 years old. If verified, this would indicate disproportionate lethal violence against a young civilian population, raising grave legal and ethical concerns.

### Why the Information Blackout Matters

The combination of alleged mass casualties and a coordinated information blackout creates an acute risk:

- Evidence may be lost, manipulated, or destroyed
- Witnesses may be silenced or disappear
- The scale of events may never be independently established

In past crises, delayed scrutiny has allowed crimes of this magnitude to be obscured. Time is a critical factor.

Photos, videos, and eyewitness testimonies from multiple locations consistently show lethal force used against unarmed civilians and mass casualties. Some reports, supported by emerging visual evidence, indicate fatalities potentially reaching into the thousands, with some sources citing figures as high as approximately 12,000. These figures require urgent, independent verification.

Given widespread internet shutdowns and restricted access for independent observers, there is an immediate risk that critical evidence may be lost or destroyed. I respectfully urge immediate steps to secure evidence, conduct independent verification, and initiate appropriate investigative measures.
